# Introduction

## 1.1 Purpose of this Report

This report addresses the status and compliance of The Village at Wellard development with the conditions in the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act) Approval 2013/6986 (EPBC 2013/6986). This report has been prepared for the purpose of meeting the requirements of condition 6 of this approval, which is to submit annual compliance reports (ACR) within three months of every 12-month anniversary of the commencement of the action for publication on the Proponent's website.

## 1.2 Project Background

The Village at Wellard development (the Project) is a joint venture between Peet Limited and the Western Australia Lands Authority (WALA) as agent for the Housing Authority, progressed under the auspices of 'Peet Southern JV Pty Limited' (Peet).

Development of the Project has been underway since 2003. Development from Stage 32 onwards will accommodate additional residential housing and Public Open Space (POS) as part of the completion of the Village at Wellard community.

## 1.3 Environmental Approval to Implement the Project

Stage 32 onwards was referred to the Department of the Environment (DotE; now the Department of Climate Change, Energy, the Environment and Water [DCCEEW]) for assessment under the EPBC Act in July 2013. Approval to implement the action was received from the Minister on 27 June 2014 (EPBC 2013/6986). The action commenced on 10 July 2014 with clearing of vegetation within Stage 33 and 34.

The proposed action is defined as follows:

*To clear native vegetation and construct a residential development on Lots 9035 and 9037, Wellard, Western Australia [see EPBC Act referral 2013/6986].*

'A variation was submitted to the Department of Agriculture, Water and the Environment [DAWE] (now DCCEEW) to extend the period of effect of EPBC 2013/6986. The variation was approved on 16 July 2020 with the new expiration date of 31 July 2025'.

## 2. Current Status

Bulk earthworks and civils were undertaken for Stage 46 in the reporting period (10 July 2022 to 9 July 2023). Approximately 0.5 ha native vegetation was cleared associated with Stage 46.

Existing firebreaks around the project were maintained during October 2022.

## 3. Audit Methodology

### 3.1 Audit Plan

#### 3.1.1 Purpose & Scope

This document has been prepared for Peet (the approval holder) to fulfil the requirements of condition 6 of EPBC 2013/6986, which was issued to enable implementation of the Residential Development of The Village of Wellard, Western Australia. Condition 6 requires:

*Within three months of every 12 month anniversary of the commencement of the action, the approval holder must publish a report on their website addressing compliance with each of the conditions of this approval over the previous 12 months.*

This ACR addresses the twelve-month period from 10 July 2022 to 9 July 2023. This ACR is due 10 October 2023.

#### 3.1.2 Methodology

The assessment was undertaken as a desktop assessment in August 2023 with consultation undertaken with appropriate personnel (Table 3.1) and accompanied by review of a variety of documents used to assess and verify compliance.

#### 3.1.3 Audit Terminology

The 'Status' field of the audit tables (refer to Table 4.1) describes the implementation of actions and compliance with the approval. DCCEEW (DotE 2014) has published Annual Compliance Report Guidelines and terminology from this guidance was applied in this audit (Table 3.2).

#### 3.1.4 Audit Evidence

Documentary evidence used to verify compliance with audit items is referenced within Table 4.1 as a unique code. Documentary evidence has been retained in electronic and/or hard copy format by the auditors. If any items have been determined to be potentially non-compliant, any available associated evidence is attached as an appendix to this report.

## 4. Audit Results

### 4.1 Compliance with conditions

The results of the audit of EPBC 2013/6986 are shown below in Table 3.1. There are eight conditions of EPBC 2013/6986, divided into 21 sub-conditions.

The results of the audit were found as follows:

- Nine sub-conditions were assessed to be “Compliant” with four categorised as Compliant (complete)
- Ten were assessed to be “Not applicable”
- Two were assessed as “Potentially non-compliant”

### 4.2 Potential non-compliances

The Potential non-compliances related to condition 6 and the late submission of the 2022 ACR:

1. The ACR was due to be published and notification provided to the Department by the 10/10/2022 however this notification was not provided until the 21/10/2022.
2. A written report is required to be sent to the Department within 2 days notifying them where a condition has been contravened. There was no explicit report of a contravention with condition 6 in the correspondence provided to the Department.

The late submission is an administrative potential non-conformance and has been reported in this 2023 ACR.

## Conditions attached to the approval

1. The **approval holder** must not **clear** more than 50.3 hectares of **Carnaby's Black-Cockatoo** and **Forest Red-tailed Black-Cockatoo foraging and potential breeding habitat** within the **project area** identified as the 'Site Boundary' at Attachment A.
2. To offset the loss of **Carnaby's Black-Cockatoo** and **Forest Red-tailed Black-Cockatoo foraging habitat and potential breeding habitat**, within three (3) months from the date of this approval, the **approval holder** must provide the **Department** with written evidence that funds have been provided to the **DPAW** for the acquisition and management of two (2) environmental **offset properties** that must be:
  - i. no less than 290 hectares in size at Lot 190 Clackline-Toodyay Road, Clackline, Western Australia; and
  - ii. no less than 37 hectares in size at Lot 1143, Wye Road, Nannup, Western Australia.

The written evidence must include a description and map clearly defining the location and boundaries of the **offset properties** and be accompanied with the **offset** attributes and a **shapefile**.

3. To avoid and mitigate impacts to the **Carnaby's Black-Cockatoo** and the **Forest Red-tailed Black-Cockatoo** during the breeding season (July – November), within 7 days prior to **clearing**, the **approval holder** must investigate **potential breeding trees** within the **project area** to detect the presence of **Carnaby's Black-Cockatoos** or **Forest Red-tailed Black-Cockatoos** using hollows. The investigation must be undertaken by a **suitably qualified and experienced person**.

If a **Carnaby's Black-Cockatoo** or a **Forest Red-tailed Black-Cockatoo** is detected using a hollow in a tree or trees, the **approval holder** must:

- clearly identify the tree or trees with fencing and signage;
- not **clear** the tree or trees; and
- undertake measures to avoid the tree or trees from being cut down, felled, removed, killed, destroyed, poisoned, ring-barked, uprooted or burned

until the hollow/s are no longer being used by the **Carnaby's Black-Cockatoo** or the **Forest Red-tailed Black-Cockatoo** as determined by a **suitably qualified and experienced person**.

4. Within 30 days after the **commencement** of the action, the **approval holder** must advise the **Department** in writing of the actual date of **commencement**.
5. The **approval holder** must maintain accurate records substantiating all activities associated with or relevant to the conditions of approval, and make them available upon request to the **Department**. Such records may be subject to audit by the **Department** or an independent auditor in accordance with section 458 of the *Environment Protection and Biodiversity Conservations Act 1999*, or used to verify compliance with the conditions of approval. Summaries of audits will be posted on the **Department's** website. The results of audits may also be publicised through the general media.
6. Within three (3) months of every 12 month anniversary of the **commencement** of the **action**, the **approval holder** must publish a report on their website addressing compliance with each of the conditions of this approval over the previous 12 months. Documentary evidence providing proof of the date of publication must be provided to the **Department** at

the same time as the compliance report is published. The compliance reports must remain on the website for 12 months from the date of publishing. Potential or actual contraventions of the conditions of the approval must be reported to the **Department** in writing within two (2) business days of the **approval holder** becoming aware of the actual or potential contravention. All contraventions must also be included in the compliance reports.

7. Upon the direction of the **Minister**, the **approval holder** must ensure that an independent audit of compliance with the conditions of approval is conducted and a report submitted to the **Minister**. The independent auditor must be approved by the **Minister** prior to the commencement of the audit. Audit criteria must be agreed to by the **Minister** and the audit report must address the criteria to the satisfaction of the **Minister**.
8. If, at any time after five (5) years from the date of this approval, the **approval holder** has not **commenced the action**, then the **approval holder** must not **commence** the action without the written agreement of the **Minister**.

## Definitions

**approval holder** - the person to whom the approval is granted, or to whom the approval is transferred under s145B of the *Environment Protection and Biodiversity Conservation Act 1999*.

**Carnaby's Black-Cockatoo** is the black cockatoo species *Calyptorhynchus latirostris*.

**clear or clearing** - the cutting down, felling, thinning, logging, removing, killing, destroying, poisoning, ring-barking, uprooting or burning of native vegetation.

**commence, commenced or commencement** - any preparatory works required to be undertaken including **clearing**, the erection of any fences, signage or on-site temporary structures and the use of construction or excavation equipment on-site for the purpose of breaking the ground for buildings, infrastructure or resource extraction.

**Department** - the Australian Government Department administering the *Environment Protection and Biodiversity Conservation Act 1999*.

**DPAW** - the Western Australian Department of Parks and Wildlife or the Western Australian Government department responsible for administering the *Conservation and Land Management Act 1984*.

**foraging and potential breeding habitat** - vegetation containing Jarrah (*Eucalyptus marginata*), Marri (*Corymbia calophylla*), Tuart (*E. gomphocephala*), *Banksia menziesii*, *B. attenuata*, *B. grandis*, *B. sessilis* and *Allocasuarina fraseriana*.

**Forest Red-tailed Black-Cockatoo** is the black cockatoo species *Calyptorhynchus banksii naso*.

**Minister** - the Minister administering the *Environment Protection and Biodiversity Conservation Act 1999* and includes a delegate of the Minister.

**offset attributes** - an excel file (.xls) capturing relevant attributes of the **offset properties**, including the *Environment Protection and Biodiversity Conservation Act 1999* reference ID number, the physical address of the offset site, coordinates of the boundary points in decimal degrees, the *Environment Protection and Biodiversity Conservation Act 1999* protected matters that the offset compensates for, any additional *Environment Protection and Biodiversity Conservation Act 1999* protected matters that are benefiting from the offset, and the size of the offset in hectares.

**offset properties** - an area approximately two hundred and ninety hectares (290 ha) in size, located at Lot 190 Clackline-Toodyay Road, Clackline, Western Australia and an area



approximately thirty-seven hectares (37 ha) in size, within Lot 1143, Wye Road, Nannup, Western Australia (identified as the Offset Area at Attachment B – attached to draft conditions of approval). These areas have been identified as environmental offset properties to be managed for conservation purposes by the **DPAW** on behalf of the **approval holder**.

**potential breeding trees** includes mature *Eucalyptus gomphocephala* (Tuart), *Eucalyptus marginata* (Jarrah) and *Corymbia calophylla* (Marri) trees with a hollow at least 20 cm in diameter and therefore large enough for a **Carnaby's Black-Cockatoo** (*Calyptorhynchus latirostris*) or a **Forest Red-tailed Black-Cockatoo** (*Calyptorhynchus banksii naso*) to nest in.

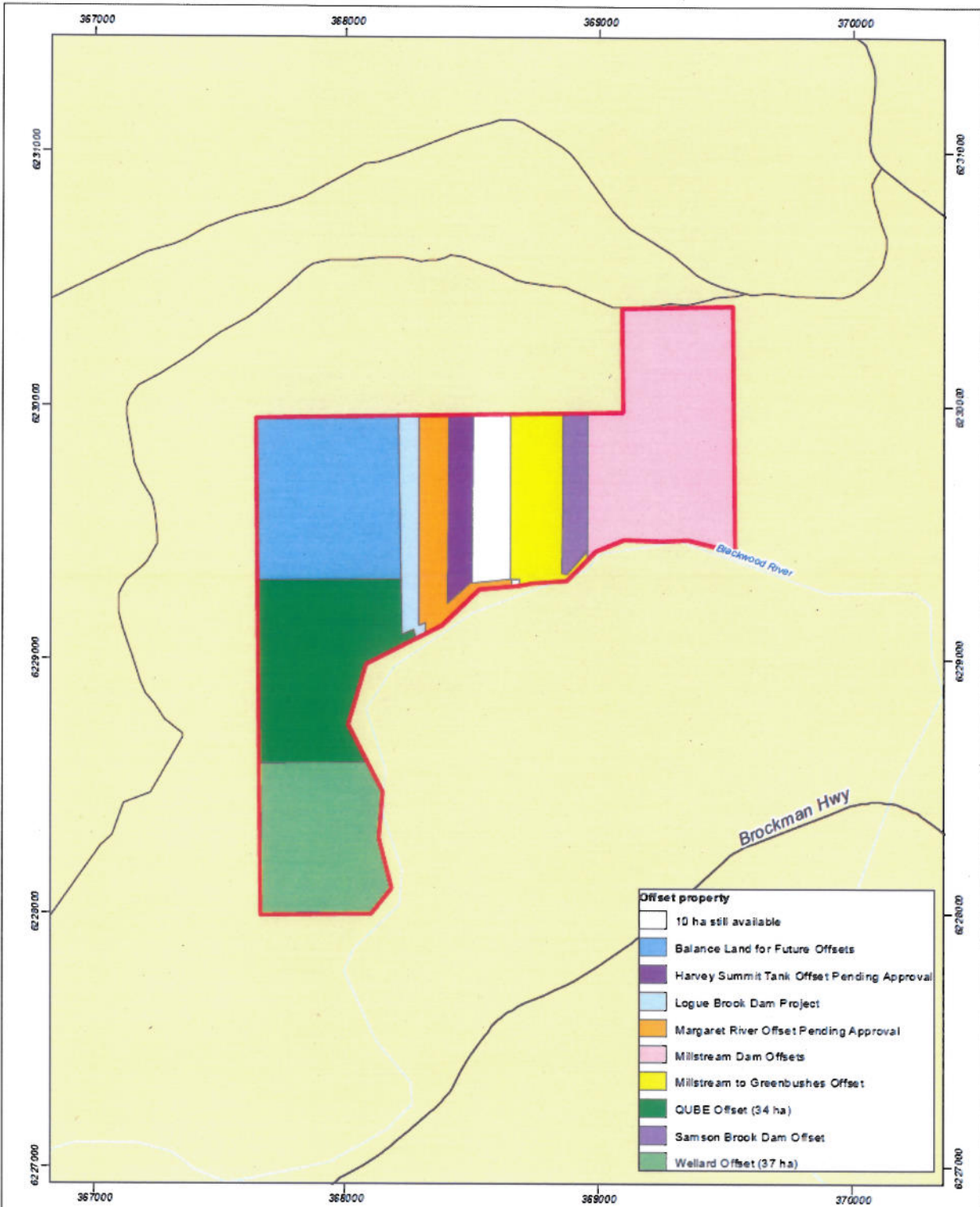
**project area** - the area at Lot 9035 and 9037, City of Kwinana, Western Australia, identified as 'Site Boundary' at Attachment A – attached to draft conditions of approval.

**shapefile** - an ESRI shapefile containing '.shp', '.shx' and '.dbf' files and other files capturing attributes of the offset area, including the shape, *Environment Protection and Biodiversity Conservation Act 1999* reference ID number and *Environment Protection and Biodiversity Conservation Act 1999* protected matters present at the relevant site. Attributes should also be captured in '.xls' format.

**suitably qualified and experienced person** - a person with relevant tertiary qualifications with experience surveying for black cockatoos.
